**Second**, these disaster losses have been exacerbated by a number of complex demographic, social, economic, and environmental changes that have rendered more people vulnerable to disaster than ever before.

**Third**, in this time of enormous disaster losses, budgets for hazards mitigation programs in the United States at the local, state, and federal levels have been significantly reduced.
