Immediately following the devastation of "Superstorm" Sandy, NHMA launched an intensive effort to support safe, proper, and thoughtful reconstruction following Sandy. We launched this effort with a joint letter to FEMA from NHMA and the Association of State Floodplain Managers. In addition, we set up special page on our website containing information on thoughtful hazard mitigation/climate adaptation beyond sea-level rise inundation areas recovery from Sandy. That webpage is available at <http://nhma.info/sandy/> and contains innovative thoughtful materials specially developed by NHMA volunteers, including French Wetmore describing a nine-step recovery process recommended for the Sandy afflicted communities. In addition, as Board President, I was interviewed by the American Planning Association (APA) to discuss how best to proceed with local recovery from Sandy. The recording of that interview is located [here](#) and on our Sandy webpage. I was also interviewed by the New York Times for an article discussing the need for higher floodplain management standards following Sandy; that article is available [here](#). It is likely that this special Sandy effort will continue and be expanded to include broader discussion for pre-and post disaster planning and preparedness. **Volunteers are most welcome! - 5) Under the leadership of Dr. Lori Peek, NHMA conducted our third annual International Hazard Mitigation Practitioners event, which is now referred to as the International Hazard Mitigation Practitioners Symposium. Thanks to the extraordinary efforts of Barry Hokanson, the draft proceedings of that event are located [here](#). The practitioners' event could not have been held without the cooperation and support from the University of Colorado's Natural Hazards Center. This event is increasingly attracting both thought leaders and thoughtful practitioners who wish to learn from each other how to approach the tremendous challenges we have of reducing the inevitable consequences of poorly designed human built development in areas subject of foreseeable natural disasters. - 6) In 2012 NHMA hired a part-time webmaster and tremendously increased the quality of the website and the materials which are available on the website.
- 7) In 2012 NHMA, under the leadership of NHMA Board Member, Dr. Kelly Klima, began a major effort to reach out to the climate change community so as to foster a linkage between Hazard Mitigation and Climate Adaptation. This partnership resulted in a well-attended webinar on the linkage between [Hazard Mitigation and Climate Change](#) in December 2012 and a webinar on February 27, 2013 on [Flood Mitigation and Adaptation in the Netherlands](#).
- 8) Under the leadership of Don Watson NHMA continued work on the development of a strategic plan. We hope to get a draft of that plan to the board and then the membership in the coming months.
- 9) Among the many policy documents and initiatives begun by NHMA in 2012, I would like to mention the special effort to reach out to the international insurance industry to discuss how hazard mitigation and the efforts of and HMA can be of enormous benefit to insurance and reinsurance carriers. **This effort is just beginning and volunteers are most welcome. Contact Ed Thomas if you are interested.**
- 10) With the help of NHMA Board Member Bob Anderson, and under the leadership of Miriam Belblidia and Dr. Michele Companion, NHMA established an International Activities Committee. We have great hopes that this committee can both spread information from the US to the World; and most especially convey information from the rest of the World to US practitioners, thought leaders, and decision makers.
- 11) NHMA finally launched a newsletter!

## NHMA Recognizes Lifetime Work of Austin's JoAnn Howard

The Natural Hazard Mitigation Association named Austin attorney and businesswoman JoAnn Howard "A National Treasure" on January 5. In granting the award, NHMA cited Howard's lifetime of work to reduce disaster losses and create safer communities. The award reads in part:

"JoAnn's successful lifetime of work includes leadership as National Flood Insurance Program administrator, president of Austin's H2O Partners, and vice president of the Natural Hazard Mitigation Association. Throughout her career, she has advocated sound risk management, wise development, prudent planning, and safe communities. Jo Ann is succeeding in her efforts to make the world a better place."

Ms. Howard is president of Austin's H2O Partners, Inc., a planning firm. NHMA President Ed Thomas presented the award to Howard at NHMA's January annual board meeting in Austin, Texas.

Ms. Howard was appointed as Federal Insurance Administrator at the Federal Emergency Management Agency in March 1998 by President Bill Clinton. Serving as the administrator of the flood program, she was responsible for managing the more than \$523 billion of flood insurance in force in the National Flood Insurance Program.

After returning to Texas in March 2001, Jo Ann Howard established H2O Partners, Inc. in Austin. H2O Partners is a firm consulting in flood insurance, hazard mitigation planning, disaster protection and recovery, public assistance, HUD programs, homeland infrastructure security, and floodplain management issues.

Prior to her tenure at FEMA, she served as a gubernatorial appointee to head the Texas Department of Insurance as chief insurance regulator for the State of Texas and as a member of the National Association of Insurance Commissioners. She received a law degree from the University of Texas School of Law in Austin, a master's in public administration from East Texas State University, and a BS in education from Abilene Christian University in Abilene.

## NHMA Represented at Gilbert F. White National Flood Policy Forum

The ASFP Foundation invited Ed Thomas to join selected experts at the fourth assembly of the Gilbert F. White National Flood Policy Forum. It was convened February 19-20, 2013, at George Mason University's Arlington Campus in the Washington D.C. area.

The Gilbert F. White National Flood Policy Forums bring together leading experts in flood policy and floodplain management to evaluate topics of critical national importance. The topic of this Forum was "Human Adjustments in Coasts – Adaptive Management in Response to Changing Hazards, Risks, and Ecosystems". Ed participated as the NHMA representative and presented a paper on "Calculating the Benefits of Risky Development Practices."

## Foresight Project Report: Reducing Risks of Future Disasters

The final report of the Foresight Project, "Reducing Risks of Future Disasters: Priorities for Decision Makers," has been published and can be accessed through: <http://www.bis.gov.uk/foresight/our-work/policy-futures/disasters/reports-documents>

This Foresight Project considered disasters resulting from natural hazards in developing countries. The aim has been to provide advice to decision makers on the difficult choices and priorities for investing in disaster risk reduction (DRR), so that the diverse impacts of future disasters can be effectively reduced, both around the time of the events and in the longer term.

The work looks out to 2040 and takes a fresh look at how science and evidence could help in understanding evolving future disaster risks, how those risks may best be anticipated, and the practical actions that could best be taken in risk reduction.

It is important that we grasp that disaster and death are not the inevitable consequence of greater exposure to hazards. It is possible to stabilize disaster impacts and save lives and livelihoods. Science has a huge role to play. However we require a change in culture and a new approach. Everyone with a stake in developing countries needs to play their part in reducing risk in a way that goes far beyond the traditional boundaries of development and disaster response.

## Apply Now for the Mary Fran Myers Scholarship

The Mary Fran Myers Scholarship Committee is now accepting applications. Recipients will receive financial support allowing them to attend the [2013 Natural Hazards Research and Applications Workshop](#) in Broomfield, Colorado, July 13-16. Recipients may also stay through July 17 to attend either the International Research Committee on Disasters or the NHMA add-on events for researchers and practitioners, respectively. Scholarships can cover part or all of transportation, meals, and registration costs.

The Mary Fran Myers Scholarship is awarded annually to at least one potential Workshop participant. Recipients are recognized at the Workshop and may be asked to serve as panelists, where they can highlight their research or practical experiences with hazards and disasters.

As the longtime co-director of the Natural Hazards Center, Myers recognized that many of the people and organizations that could benefit from and contribute to the Workshop—including local practitioners, students, and international professionals—were among those least likely to afford it. The scholarship was established in 2003 to fulfill Myers' request that qualified and talented individuals receive support to attend.

This year, hazards practitioners, students, and researchers with a strong commitment to disaster management and mitigation and who reside *outside* North America or the Caribbean are eligible to enter. Eligibility is based on current place of residence, not citizenship. Applicants from North America and the Caribbean will be eligible for the scholarship in 2014. Previous attendees of the Natural Hazards Workshop are *not* eligible for the 2013 Mary Fran Myers Scholarship. Preference is given to those who can demonstrate financial need.

## Communities Showcase that Flooding Can – and Has – Happened Here: FEMA’s New “Know Your Line” High Water Mark Initiative

Nearly every community in the United States is at risk for flooding but most Americans do not believe they are at risk. To improve the public's awareness of flood risk and encourage them to take action to reduce it, FEMA and seven other Federal agencies developed the "Know Your Line: Be Flood Aware" initiative.

The Know Your Line initiative helps communities showcase their local flooding history and motivate their residents to take action by posting high water mark signs in prominent places to show how high flood waters have risen in the past. Communities are encouraged to hold a high profile event to announce the initiative, followed by a wide range of supporting activities to remind residents of their flood risk over time and prompt them to take steps to reduce it. Additionally, communities that reach out to the public to help prevent the effects of flooding through the Know Your Line initiative:

- Underscore their commitment to the well-being of residents and the local business community
- Galvanize their community to take steps now to reduce the often devastating impact of floods
- Can apply to receive Community Rating System Rating (CRS) points to reduce the cost of flood insurance
- Can put existing applicable Federal and state mitigation assistance funds to work

To inform the initiative, FEMA and its partners are currently working with communities nationwide to conduct pilot projects. The pilots will help refine the initiative's materials, messages, and create new materials that communities may need to better communicate their flood risk. Currently, there are four pilot communities including Frankfort and Franklin County, KY, Harrisburg, PA, Orange Beach, AL, and Nashville, TN. These communities anticipate launching their initiatives by April 2013, in preparation for a national rollout of the initiative.
