Course Description:

The National Emergency Management Advanced Academy (NEMAA) reinforces the qualities needed to lead emergency management programs, provides relevant management theories and concepts, and utilizes appropriate case studies. Advanced Academy participants work within a collaborative environment on projects and establish a network of peers.

NEMAA is designed for Emergency Management mid-level managers with a minimum of three (3) years experience in an Emergency Management position wanting to advance their skill set. Students learn skills critical to performing emergency management responsibilities such as: program management and oversight, effective communication at all levels, integrated collaboration, and strategic thinking, along with completing a Research Project one month prior to attending the final course.

The Research Project provides students the opportunity to demonstrate their critical thinking abilities. Students apply the key learning concepts from the Advanced Academy curriculum relative to their own strengths and weaknesses, their organizations, and their own performance environments.

Course Requirements:

The NEMAA Program consists of four (4), five (5) days courses. Attendance at each course is required and must be attended in the following sequential order:

E0451 Advanced I – A Survey of Advanced Concepts in Emergency Management

E0452 Advanced II – Assessment and Application of Professional Style in Emergency Management

E0453 Advanced III – Advanced Concepts and Issues in the Emergency Management Organization

E0454 Advanced IV - Advanced Concepts and Issues in the Emergency Management Community and Profession

Target Audience:

This course is intended for government, non-profit voluntary organizations, and private sector leaders responsible for emergency management or homeland security, including:

- State, local, tribal, and territorial emergency management or homeland security program Directors or Deputies.
- Federal department heads or branch chiefs of emergency management or homeland security offices or programs.
- University Emergency Management Directors or Deputies.
- Deputy Directors and managers of non-profit voluntary organizations.
- Private sector managers leading emergency management offices and related programs.

To Register:

Applications will be accepted between July 2 - November 2, 2018. Each application must include the following items, submitted in the order listed below:

- A General Admissions Application Form or [FEMA Form 119-25-1](#) (Item 9.a. on the form should state, "L0451 National Emergency Management Advanced Academy.").
- The applicant's signed [commitment statement](#) indicating their commitment to complete the entire program to include the four courses and the NEMAA Paper.
- A resume not to exceed two (2) pages (no required format).
- A cover letter from the applicant, not to exceed one (1) page, requesting admission to the program and specifying the applicant's qualifications and perceived expectations of the program (no required format).

- A letter of recommendation from your Supervisor.

FEMA Form 119-25-1 Application:

Applicants will need to put their Student Identification (SID) in place of their social security number. If you do not yet have a SID, just follow these three simple steps to obtain one:

Step 1: To register, go to: <https://cdp.dhs.gov/femasid/>.

Step 2: Click on the “Register for a FEMA SID” button in the middle of the screen.

Step 3: Follow the instructions and provide the necessary information to create your account.

Enrollment confirmations will be sent approximately 30-days prior to the course via email.
