

The FMA and BRIC grant programs provide states, local communities, tribes and territories funding for eligible mitigation activities to reduce the risks they face and the impact of future disasters.

Application will be accepted between today, September 30, 2020, and January 29, 2021. Eligible applicants must apply for funding through FEMA Grants Outcomes (GO), which is FEMA's new grant management system. FEMA GO streamlines the processing of grants to ensure successful application submissions and awards.
